

### **NPLs in CESEE: Continued Improvement**

(December 2016 data)



- NPLs in CESEE have continued to gradually decrease, with the NPL volume recording a €5.9bn drop from June 2016 to €46.7bn as of December 2016- this is mostly explained by NPLs sales.
- The average NPL ratio in the region stands at 6.2% while the average NPL Coverage Ratio remains stable at around 62.5%.




#### Snapshot of NPLs in CESEE

### NPL resolution – best practices



- Clarity on Bank Secrecy Rules => availability of data on VDR for auction sales
- Adequate provisioning policies => bridging the pricing gap for sales
- Accurate collateral valuation => improve bid price
- Investor-friendly licencing requirements/regulation => develop local servicing capacity
- Removal of tax disincentives (e.g. on write-offs) => develop/support NPL sales
- OOCR and training of judges => Facilitate corporate/SME restructuring
